Therefore, patients should adequately supplement with calcium and vitamin D. *Due to risk of osteonecrosis of the jaw, prescriber should perform routine oral exam prior to treatment. *Contraindicated in patients with a CrCl less than 35mL/min and in those with evidence of acute renal impairment.
